Approval of Minutes:

Mr. Jansen asked the Advisory Committee members to consider the minutes from the January 11, 2018 "regular" meeting.

Upon a motion made by Mr. Shannon, and seconded by Mr. Mendelson, the Advisory Committee members voted unanimously in favor of approving the minutes, as presented, from the January 11, 2018 "regular" meeting. New Investment Proposal:

"Vouchr Ltd. - Toronto, ON"

Mr. McCooe discussed the proposed new investment in Vouchr Ltd. He stated that Voucher Ltd. Is an early-stage Fintech company seeking entry into global markets. He then went on to give an overview of the company.

A discussion ensued.

Upon a motion made by Mr. Jansen, and seconded by Mr. Mendelson, the Advisory Committee members voted unanimously in favor of recommending to the Eli Whitney Investment Committee that financing be approved in an amount of up to \$1,000,000 for product development, sales and marketing, and working capital in Vouchr Ltd.

4. Follow-on Investment Proposal:

"Surface Travel, Inc. (d/b/a Curacity) - Stamford, CT"

Mr. McCooe discussed the proposed follow-on investment in Surface Travel d/b/a Curacity. Mr. McCooe explained that Surface Travel d/b/a Curacity is an early stage marketing technology and data company increasing hotel bookings via media, advertising and an online booking engine. Mr. McCooe then went on to discuss Cl's investment history with the company.

A discussion ensued.

Upon a motion made by Mr. Jansen, and seconded by Mr. Mendelson, the Advisory Committee members voted unanimously in favor of recommending to the Eli Whitney Investment Committee that the requested changes to the previously approved financing of March 2, 2017 are approved for the purposes of hiring and working capital in Surface Travel, Inc. (d/b/a Curacity).
