Approval of Minutes:

Mr. Santiago asked the Advisory Committee members to consider the minutes from the August 9, 2018 "regular" meeting.

Upon a motion made by Mr. Shannon, and seconded by Mr. DePardo, the Advisory Committee members voted unanimously in favor of approving the minutes, as presented, from the August 9, 2018 "regular" meeting.

New Investment Proposal:

"Aureus Analytics - Hartford/Singapore"

Mr. Longo and Mr. Boyle discussed the proposed new investment in Aureus Analytics. Mr. Longo stated that Aureus Analytics is an enterprise SaaS company which provides advanced artificial intelligence enabled data analytics for risk/claim prediction, cross-sell potential, fraud prevention, policyholder retention, and customer sentiment insights to property and casualty insurance companies.

Mr. Longo asked the Eli Whitney Advisory Committee to enter executive session to discuss Aureus Analytics.

Upon a motion made by Mr. DePardo, and seconded by Mr. Shannon, the Advisory Committee members voted unanimously in favor of recommending to the Eli Whitney Investment Committee that financing be approved in an amount of up to \$750,000 for the purposes of sales and marketing and working capital in Aureus Analytics.
