A discussion ensued.

Upon a motion made by Ms. Maerz, and seconded by Dr. Cuffaro, the Investment Committee members voted unanimously in favor of approving financing from the SSBCI funds in an amount of up to ONE MILLION THREE HUNDRED SIXTY THOUSAND DOLLARS (\$1,360,000), as presented, in Avitus Orthopedics, Inc.

# ProteoWise, Inc, - New Haven, CT

Mr. Wagner and Dr. Lewis provided an overview of a proposed follow-on investment in ProteoWise, Inc. Mr. Wagner then went on to discuss Cl's investment history with the company, the current funding round, and the use of proceeds.

A discussion ensued.

Upon a motion made by Dr. Cuffaro, and seconded by Ms. Maerz, the Investment Committee members voted, with one abstention, in favor of approving financing from the SSBCI funds in an amount of up to ONE MILLION FIVE HUNDRED THOUSAND DOLLARS (\$1,500,000), as presented, in ProteoWise, Inc.
