2. Approval of Minutes:

Mr. Pavia asked the Investment Committee members to consider the minutes from the June 22, 2023, regular meeting.

Upon a motion made by Dr. Cuffaro and seconded by Mr. Cantor, the Investment Committee members voted unanimously in favor of approving the minutes, as presented, for the June 22, 2023, regular meeting.

3. New Investment Proposal:

E-Zinc, Inc – Toronto, Canada

Mr. Drakonakis, Mr. Dings, and Mr. D'Alelio discussed the proposed new investment in E-Zinc, Inc. Mr. Drakonakis stated E-Zinc, Inc. is a Toronto-based company commercializing a breakthrough electrochemical technology for storing energy in zinc metal.

A discussion ensued.

Upon a motion made by Dr. Cuffaro, and seconded by Mr. Swanston, the Investment Committee members voted, with one abstention, in favor of approving financing by the Eli Whitney Fund in an amount of up to TWO MILLION DOLLARS (\$2,000,000), as presented, in E-Zinc, Inc.

4. Follow-on Investment Proposal:

Intellihealth, Inc. - New Canaan, CT

Mr. Storeygard and Ms. Malloy provided an overview of a proposed follow-on investment in Intellihealth, Inc. Ms. Malloy then went on to discuss Cl's investment history with the company, the current funding round, and the use of proceeds.

A discussion ensued.

Upon a motion made by Mr. Swanston, and seconded by Dr. Cuffaro, the Investment Committee members voted unanimously in favor of approving financing from the SSBCI funds in an amount of up to ONE MILLION DOLLARS (\$1,000,000), as presented, in Intellihealth, Inc.

5. Other Business:

CoolIT Systems, Inc. - Alberta, Canada/Stamford, CT

Mr. McCooe provided an update on CoolIT Systems, Inc. that included a recent transaction.

A discussion ensued.

Upon a motion made by Mr. Swanston and seconded by Dr. Cuffaro, the Investment Committee members voted unanimously in favor of the transaction, as presented, in CoolT, Inc.
