Tax Relief Program established under CGS §32-23h, in an Amount Not to Exceed a Total of \$700,000 over a period not to exceed 5 years, for the benefit of Home Market Foods, Inc., in South Windsor, CT, with the terms and conditions recommended by staff, as presented.
